While preparing statement of Liquid capital balance the amount of Rs. 4,488,268 retained by Pakistan Stock Exchange had been included in liquid capital that is not in accordance with the requirement of Third Schedule of the Securities Broker Licensing Regulation 2016 had the amount is not included the Liquid Capital balance would have been reduced by Rs. 4,488,268.

In our opinion except for the non-compliance given in the above paragraph, the financial information in the statement of the Securities Broker as at 31st December 2017 Is prepared, in all material respects, in accordance with the requirements of the Third Schedule of the Securities Brokers (Licensing and Operation) Regulations, 2016 (the Regulations) issued by the Securities & Exchange Commission of Pakistan (SECP).

Basis for Opinion

We conducted our audit in accordance with International Standards on Auditing (ISAs) as applicable in Pakistan. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the statement section of our report. We are independent of the Securities Broker in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Emphasis of Matter -- Basis of Accounting and Restriction on Distribution

We draw attention to Note X to the statement, which describes the basis of accounting. The statement is prepared to assist **Oriental Securities (Private) Limited** to meet the requirements of the SECP, Pakistan Stock Exchange (PSX) and National Clearing Company of Pakistan Limited (NCCPL). As a result, the statement may not be suitable for another purpose. Our report is intended solely for **Oriental Securities (Private) Limited**, SECP, PSX and NCCPL and should not be distributed to parties other than **Oriental Securities (Private) Limited**, the SECP, PSX or NCCPL. Our opinion is not modified in respect of the matter except for the matter stated above.

Responsibilities of Management and Those Charged with Governance for the statement

Management is responsible for the preparation of the statement in accordance with the Regulations, and for such internal control as management determines is necessary to enable the preparation of the statement that is free from material misstatement, whether due to fraud or error. Those charged with governance is responsible for overseeing the Securities Broker's financial reporting process.

Auditor's Responsibilities for the Audit of the statement

Our objectives are to obtain reasonable assurance about whether the statement is free from material misstatement whether due to fraud or error, and to issue an auditor's report that includes our opinion.
